## What is A Report by A CASp and Why Should it Matter

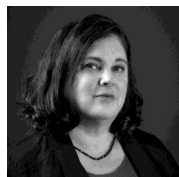
### SEMINAR/WEBINAR:

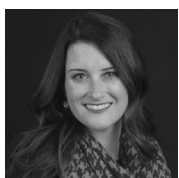

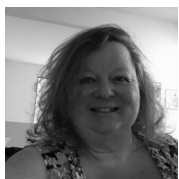
### SPEAKERS:
